2025 Boys & Girls Clubs of the Sun Corridor Territorial Party 2, 50/50 Raffle Official Rules

- 1. **General.** By participating in the 2025 Boys & Girls Clubs of the Sun Corridor Territorial Party 2, 50/50 Raffle ("Raffle"), entrants agree to be bound by these Official Rules and by the decisions of the Boys & Girls Clubs of the Sun Corridor, Inc. ("BGCSC"), which shall be binding and final as to all matters related to the Raffle. The Raffle is subject to all applicable federal, state, and local laws and is void where prohibited.
- 2. **Jackpot.** The "Jackpot" shall be the total proceeds from raffle tickets sold for that drawing ("Raffle Tickets"). Fifty percent (50%) of the Jackpot will be awarded to the winner, and fifty percent (50%) will benefit the Boys & Girls Clubs of the Sun Corridor and the programs it supports. The Jackpot will be publicly posted prior to the drawing.
- 3. **Proceeds to BGCSC.** Fifty percent (50%) of the Jackpot will be retained by BGCSC, a 501(c)(3) public charity, and will be used to support programs that improve recreational, educational, health, and social services for children and families in need.
- 4. **Eligibility.** The Raffle is open only to persons who, at the time of entry, are located in the State of Arizona and are eighteen (18) years of age or older. BGCSC board members, officers, employees, and persons involved in the conduct, operation, administration of the Raffle, their immediate family members (meaning spouse, parent, child, sibling, and their respective spouses, regardless of where they reside), persons residing in their same household, and any contractor or other person or vendor that fulfills a role for, or exerts any influence over, the Raffle, or in any way administers, or has access to, entries or the selection of a winner, are not eligible to win the Prize. This eligibility exclusion does not apply to BGCSC board members, officers, or employees, who have no role in, or operational control or influence over, the Raffle. By participating in the Raffle, entrants agree to these Official Rules.
- 5. **Purchasing Raffle Tickets.** Raffle Tickets may only be purchased online at TerritorialParty.com from September 22, 2025, through November 21, 2025 at noon, during the Territorial Party event held at the Casa Grande Community Recreation Center. Ticket prices are as follows:
 - 1 entry for \$5
 - 5 entries for \$20
 - 20 entries for \$50
 - 50 entries for \$100
 - 150 entries for \$250
 - 350 entries for \$500

Each Raffle Ticket purchase will be assigned a unique number, tracked along with the entrant's contact information. All Raffle Ticket purchases are final, and no refunds or replacements will be issued by BGCSC. Purchases must be made during the designated selling period, which ends at noon on November 21, 2025. There is no limit to the number of tickets an individual may purchase.

6. **Raffle Tickets are Not Tax Deductible.** The IRS has determined that amounts paid for chances to participate in raffles are not considered gifts and, therefore, the price of the entry does not qualify as a deductible charitable contribution.

- 7. **Prize.** Each winner will receive a prize equal to fifty percent (50%) of the Jackpot.
- 8. **Taxes.** The winner is responsible for any and all travel, costs, federal, state, and local income or excise taxes, fees, assessments, and like charges associated with the prize. Federal and state withholding laws in effect at the time the prize is awarded will be followed, and any required withholdings will be deducted before the prize is distributed.
- 9. **Selection of Winner.** The Raffle drawing will be held on Friday, November 21, 2025, and broadcast on BGCSC's Facebook page. A random number generator will be used to select the winning entry from all valid ticket purchases. The contact information associated with the winning Raffle Ticket will be announced as the winner of the 50/50 Raffle. The winning amount will be fifty percent (50%) of the final total sales for the 50/50 Raffle.
- 10. **Prize Claim.** The prize claimant must notify BGCSC and provide verifiable proof that the claimant is the rightful owner of the winning Raffle Ticket within thirty (30) days of the drawing to claim the prize. The claimant must provide all necessary information for tax purposes and complete an Affidavit, Prize Claim, and Release form ("Release"). Failure to provide the required documentation or to notify BGCSC within the allotted time will result in forfeiture of the prize, which will be retained by BGCSC for charitable use. The prize will be distributed via check within thirty (30) days after the winner has submitted all required documentation.
- 11. **Odds.** The odds of winning depend on the number of Raffle Tickets purchased for the applicable drawing.
- 12. **Transfer of Raffle Tickets or Prize.** Raffle Tickets may be gifted to other eligible persons, but any person receiving a gifted Raffle Ticket must meet the eligibility requirements outlined in these rules. Raffle Tickets may not be resold, and any tickets found to be resold will be void. A winner may transfer their prize to a third party, provided that the transferee meets the eligibility requirements and accepts all associated tax obligations.
- 13. **Administration.** The Raffle will be conducted and supervised by BGCSC, whose decisions are final. BGCSC reserves the right to modify these Official Rules at any time.
- 14. **Release of Liability.** By participating in the Raffle, entrants agree to release BGCSC, its sponsors, affiliates, and representatives from any and all liability for claims, injuries, losses, or damages arising out of participation in the Raffle or use of the prize.
- 15. **Publicity Release.** By accepting a prize, the winner grants BGCSC permission to use their name, likeness, and prize information for promotional purposes without further compensation, unless prohibited by law.
- 16. **General Conditions.** BGCSC is not responsible for late, incomplete, or misdirected entries or for any technical issues that may prevent an entry from being submitted or a winner from being contacted. BGCSC reserves the right to disqualify any entrant for tampering with the entry process or violating these Official Rules. In the event of cancellation of the Raffle for any reason, BGCSC reserves the right to select a winner by random drawing from among all eligible entries received up to the time of cancellation.
- 17. **Governing Law.** The Raffle and these Official Rules are governed by the laws of the State of Arizona.
